How are the ICC and ICJ structured? What is the purpose of courts that supersede national judiciaries? Can they be effective? Do international courts risk delegitimizing weaker judiciaries?

What has been the result of an increased focus on governance by bodies such as the World Bank? What has been the impact of this focus on governance structures specifically in developing countries? What lessons have been learnt from the successes and failures of previous governance focused restrictions on development aid?

What is the Executive role of the Commission and how does it operate? What is the role of Commissioners and how do they negotiate between national and EU interests? How does the Commission relate to the other EU organs of governance?

Formed by the Treaty of Lisbon the EEAS serves as the foreign ministry and diplomatic corps for the EU. How was the EEAS created? What is its anticipated role? What developments have taken place to institute a diplomatic corps for the EU?

What is the role of the Presidency? How is the Council of Ministers Structured? How does it function? How are their meetings organised and agenda items agreed? What is the legislative function of the Council? What is the relationship between the Council of Ministers and the European Council?

The European Parliament

How are MEPs elected? How is the number of seats allocated to each country calculated? How do MEPs negotiate between national and European interests? How do MEPs group themselves and how do party alliances operate across nationalities? What is the legislative and scrutiny role of the European Parliament? How does the Parliament relate to other EU organs of governance?

How is the ECJ structured? What is the role of the ECJ in ensuring the application of EU law across member states? What is the nature of the relationship between national courts and the ECJ?

Presentation of case studies detailing supranational governance. Using the case studies to lead discussion, delegates consider: what are the benefits and risks of supranational governance structures? Is trade the necessary impetus for integration between nations? Are supranational organisations that focus on cooperation rather than integration more effective?

The Commonwealth as an institution frequently performs a 'good-offices' role; what role is there for the Commonwealth in facilitating co-operation on the governance of international issues? What role is the

Commonwealth, as a supranational organisation, playing in assisting member nations to improve the governance of their countries?

What is the historical background of the Westminster model? What are its key defining features? How does the UK system compare with others around the world? What have been the most recent reforms to the UK system?

What is the role of opposition parties in Parliament and in scrutinising the Executive?

What can be done to strengthen and develop these institutions? What reforms and adaptations to the Westminster System have delegates found most effective?

How is regional policy formulated? How is legislation developed and passed through the Assembly? How is the relationship between the UK Parliament and the Welsh Assembly structured? How is policy implemented and developed at a regional level? What is the relationship between national and regional parties with regards to policy?

How do coalition governments affect governance? How can coalition governments encourage consensus rather than adversarial politics? What is the effect of coalition politics on policy and scrutiny? Can coalition governments generate greater trust in the political process?

How do electoral systems differ across countries? What is the structure of international observation missions to elections? What is the role of international organisations in improving the democratic process?

Why are the public in some countries disengaging from politics? How can parliamentarians engage better with the electorate? How can Parliamentarians work to restore trust through transparency?

Should management of the public sector be focused on perceived needs or measurable outputs? How can parliamentarians most effectively provide oversight for the public sector? How can management of the public sector be undertaken to encourage citizen empowerment and downward accountability?
